# Kerry Bamrick, MBA

#### Executive Director of the National Nurse Practitioner Residency & Fellowship Training Consortium

Kerry Bamrick is the Executive Director for the National Nurse Practitioner Residency & Fellowship Training Consortium (NNPRFTC). In this role, she serves as the key management leader of the NNPRFTC. Bamrick is responsible for overseeing the administrative, fiscal, and technical, programs, and services of the NNPRFTC while carrying out the strategic plan of the organization. As the Executive, key responsibilities include oversight of the development, implementation, and operation of the Accreditation Commission of the organization in accord with the rules governing that Commission, supporting the business growth and development of accreditation business for the NNPRFTC, and achieving/ maintaining USDE recognition as an accreditation organization. Over the last twelve years, she has been directly involved in the growth and development of the organizations to becoming its own 501c3. In addition, Bamrick was a member of the accreditation planning committee and contributed to the development of consortium's accreditation standards. She served as both faculty and trainee in the online accreditation site visitor-training program, was directly involved in CHCl's Nurse Practitioner residency program accreditation application and participated on an NP residency accreditation site visit as an "observer" in 2018.

Bamrick is a recognized leader in the area of postgraduate nurse practitioner residency training. She has extensive experience in both managing postgraduate nurse practitioner residency training programs and serving as a content expert to organizations interested in implementing postgraduate residency and fellowship programs. Prior to becoming the Executive Director, she managed CHCI's remotely hosted nurse practitioner residency programs in the states of California, Hawaii, Illinois, Indiana, Massachusetts, New York, Oregon, Rhode Island, and Washington. Bamrick served as the Co-Principal Investigator for HRSA's National Cooperative Agreement (NCA) on Clinical Workforce Development focused on providing training and technical assistance to health centers interested in transforming teams and training the next generation. Her passion and interest in this field is reflected in her work nationally.

Bamrick has an undergraduate degree from Merrimack College and a Master's Degree in Business Administration from Western New England College.

### Associate Adjunct Professor at the University of California, San Francisco; President and CEO of HealthImpact

Dr. Garrett Chan is Associate Adjunct Professor at the University of California, San Francisco, and President and CEO of *HealthImpact*, the California designated nursing workforce and policy center. His scholarship and policy work has focused on palliative care and emergency nursing, advanced practice registered nursing scope of practice and education, and nursing workforce strategy and development. He was the Director of Advanced Practice at Stanford Health Care where he created the advanced practice provider fellowship in specialty practice.

Dr. Chan has practiced as a critical care/emergency/trauma and palliative care certified clinical nurse specialist and an emergency/critical care and urgent care certified nurse practitioner in community and academic medical centers. Dr. Chan has been working with academic institutions, healthcare systems, policy organizations, and governments in Norway, Japan, and Switzerland to create the role and educational standards for advanced practice nursing in those countries.

Dr. Chan earned his BSN from San Jose State University, his Master's and PhD at the University of California, San Francisco, completed the National Institute of Nursing Research Summer Genetics Institute as a postdoctoral fellow, and graduated from the Senior Executive Program of the American College of Healthcare Executives. Dr. Patricia Dennehy is the Owner and Principal of Dennehy & Associates LLC, a Nurse Practitioner owned consulting firm.

Dr. Dennehy has worked with the leadership of LA County Department of Health Services (LACDHS) on projects examining the roles of advanced practice providers throughout the system. She has also led projects focusing on improving team-based care involving the use of quality improvement projects to engage staff and improve care outcomes, patient safety, and the care environment. She was the Project Director for LACDHS on a 3-year 1.5M grant from HRSA for Inter-professional Collaborative Practice which includes educational and practice outcomes. Currently she leads a team establishing an organizational approach to Nurse Practitioners within this large public system of care.

Prior to her work in LA, Dr. Dennehy was a Principal Consultant for Health Management Associates. She led many projects including a 3-year grant with the State of Idaho taking 55 primary care practices through Primary Care Medical Home (PCMH) recognition/certification a year (total 165 practices over project period).

While at UCSF she was an Assistant Professor of Nursing and Director of Glide Health Services in San Francisco. Glide Health Services was a collaboration between the School of Nursing, Glide Foundation, Catholic Healthcare West-Saint Francis Memorial Hospital, and the San Francisco Department of Health Services. Her work there was funded by multiple sources including HRSA Division of Nursing and Public Health and many private foundations. She was the lead of the first HRSA grants for NP Residencies granted to UCSF/Glide and included UCLA as a sub-recipient.

Dr. Dennehy is a healthcare leader and strong spokesperson for nursing's contribution to healthcare access and quality. She has served on the Board of Directors for the following organizations: National Nurse Practitioner Residency & Fellowship Training Consortium, National Nursing Centers Consortium, and the San Francisco Community Clinic Consortium. She has provided testimony to the California Senate and has been invited to a White House Meeting for nurse leaders to discuss implementation of the ACA. She was appointed to an advisory panel at NIH on Genomics and practice.

Dr. Dennehy received her BSN and FNP from Sonoma State University, MSN from the University of California San Francisco and DNP from Rush University. In 2012, she was the recipient of the lames Irvine Leadership Award for her "creative and inspirational leadership benefiting the people of California" for increasing the access to primary care through the use of nurse practitioner providers in expanded roles. In 2014, she received the Dr. Francis Curry Award for promoting the role of nurses in primary care.

### Mitchel Erickson, BSN, MSN, ACNP

#### Associate Chief of Advanced Practice at UCSF Health

Mitchel Erickson graduated from the University of British Columbia in 1981 in Food Science and Human Nutrition and again from the School of Nursing in 1989. Between those degrees he engaged in bench research at UBC in both Nutritional Sciences and in Psychiatry. The psychiatric genetics research took him to Columbia University doing site research in Prince Edward Island in a joint effort with UBC. He has engaged in nursing student advocacy and lobbying in Canada and in California. In 1990, he immigrated to the United States and completed his graduate education at the University of California San Francisco in 1997 and has held several clinical and administrative positions. He was the first nurse practitioner hospitalist at UCSF Health to bring more advanced practice providers to inpatient management and then moved to Emergency Medicine to practice as the first advanced practice provider to pioneer the broad management of all clinical presentations.

Erickson filled the first Associate Chief of Advanced Practice role for UCSF Health in 2016 overseeing the practice of more than 600 advanced practice providers. He worked to foster the growth of an ANCC accreditation for the NP Fellowship Program and has holds a joint appointment as an associate clinical professor at the UCSF School of Nursing. He is the current elected Chair of the California Board of Registered Nursing's Advanced Practice Advisory Committee and initiated the University of California APP Strategy Committee for all the UC Health Systems in California. He has held several board positions with Doctors for Global Health (DGH), a non-profit organization partnering with communities around the globe supporting their efforts to create a healthy community through accompaniment and liberation medicine.

#### Margaret M. Flinter, APRN, PhD, FAAN, FAANP, c-FNP

# Senior Vice President and Clinical Director at Community Health Center, Inc.; Founder Emeritus of the Weitzman Institute

Dr. Margaret Flinter is the Senior VP and Clinical Director of the Community Health Center, Inc. (CHCI), a statewide federally qualified health center serving 150,000 patients from its primary care centers across Connecticut, while leading practice transformation initiatives across the country. A family nurse practitioner since 1980, she has held progressive roles in the organization as both primary care provider and executive leader. She founded the Weitzman Institute, CHCI's research, innovation, and education arm in 2005.

Flinter served as the national co-director of the Robert Wood Johnson Foundation's Primary Care Teams: Learning from Effective Ambulatory Practices (LEAP) project, which studied exemplar primary care practices across the country. She has led the national development of a model of postgraduate residency training programs for new nurse practitioners and established the National Nurse Practitioner Residency & Fellowship Training Consortium. Flinter is the Principal Investigator for HRSA's National Cooperative Agreement on Clinical Workforce Development and for the past ten years, has been the co-host of a weekly radio show, "Conversations on Health Care", which connects people with issues of health policy, reform, and innovation. She speaks widely on topics related to leadership and primary care transformation.

Flinter received her BSN from the University of Connecticut, her MSN from Yale University, and her PhD at the University of Connecticut. She is a fellow of the American Academy of Nursing and the American Academy of Nurse Practitioners.

#### Angela Forbes, ARNP

#### Inpatient Chief Clinical Officer, APP Fellowship Supervisor, and Pediatric Nurse Practitioner at Seattle Children's Hospital

Angela Forbes is a pediatric nurse practitioner in the cancer care unit at Seattle Children's Hospital. She began her career at Seattle Children's Hospital as a cancer care unit coordinator, and having been inspired by the nurses in her unit, she went on to pursue a career in nursing. Since 2017, Forbes has been a member of the leadership team for the Advanced Practice Provider (APP) Fellowship and is currently the Interim Fellowship Director.

Forbes received her undergraduate degree from Seattle Pacific University and then went on to work as a pediatric oncology nurse at Seattle Children's Hospital. She earned her master's degree from New York University, where she was honored as the Distinguished Graduate and received the Division of Nursing Alumni Association Master's Achievement Award. After graduation, she worked at Memorial Sloan Kettering Cancer Center, specializing in caring for critically ill children with cancer and other immunological diseases. Forbes returned to Seattle Children's Hospital in 2011 to continue her career. She has spoken internationally, nationally, and locally about the care of pediatric patients.

As the principal of Bridgestone Consulting, Dr. DoQuyen (Quyen) Huynh is an innovative leader with a decade of primary care experience, programmatic development, business strategies, and public speaking. She specializes in postgraduate residencies and fellowships for advanced practice clinicians, with expertise in adult learning and clinical education.

In her previous work at International Community Health Services (ICHS), Dr. Huynh provided primary care to diverse populations in the greater Seattle area from 2010–2020. She created and directed one of the most successful Nurse Practitioner Residency programs in the country which has served as the benchmark for many to follow. interprofessional education and practice between the NP, dental, and medical residencies, along with other clinical internships and externships at ICHS. Dr. Huynh is dedicated to social justice, through providing healthcare to underserved populations and building the next generation of clinicians to serve those most vulnerable in our society.

In 2014, she founded the Northwest Consortium of Advanced Practice & Education (NW CAPE) which is a platform for 14 organizations to collaborate and grow their postgraduate training programs in the Pacific Northwest. In 2015, Dr. Huynh was appointed to the board of the National Nurse Practitioner Residency & Fellowship Training Consortium (NNPRFTC), and continues to chair the organization's Accreditation Commission to oversee national accreditation, and to seek federal recognition of nurse practitioner postgraduate training programs.

She was selected by the American Association of Nurse Practitioners to be Washington State's Nurse Practitioner of 2017, Award of Excellence. Outside of healthcare, she is an active entrepreneur of more than 15 years, with a diverse portfolio in real estate investment, wedding and entertainment industry services, and restaurant development, all of which informed her business strategies.

Dr. Huynh received a BA from the University of Washington before earning her BSN, MSN, and DNP in Systems Leadership from Seattle University.

# Mitch Katz, MD

#### **Chief Executive Officer at NYC Health + Hospitals**

Dr. Katz is the President and Chief Executive Officer of NYC Health + Hospitals, the largest municipal health system in the United States, with 11 acute care hospitals, 5 skilled nursing facilities, dozens of community health centers, a home care agency, and an insurance plan, MetroPlus Health. He was appointed January 8, 2018. During his first year, Dr. Katz has focused on advancing the transformation of the public health care system with numerous new initiatives to expand access to primary care services, reduce administrative costs, invest in more front-line clinical staff, and build financial stability.

Previously, Dr. Katz was the Director of the Los Angeles County Health Agency, an agency that combines the Departments of Health Services, Public Health, and Mental Health into a single entity so as to provide more integrated care and programming within Los Angeles. The Agency has a budget of 7 billion dollars, 28,000 employees, and a large number of community partners. Dr. Katz served as the Director of the Los Angeles County Department of Health Services (DHS), the second largest public safety net system in the United States. During this time, he created the ambulatory care network and empaneled over 350,000 patients to a primary care home. He eliminated the deficit of DHS through increased revenues and decreased administrative expenses, and used the new ACA funding to pay for an integrated electronic health system. He moved over 4,000 medically complex patients from hospitals and emergency departments into independent housing, thereby eliminating unnecessary expensive hospital care and giving the patients the dignity of their own home. Dr. Katz continued to see patients every week as an outpatient physician at Edward R. Royal Comprehensive Health Center and on the inpatient medicine service at LAC+USC, Harbor-UCLA, and Olive View–UCLA Medical Centers.

Before he came to Los Angeles, Dr. Katz was the Director and Health Officer of the San Francisco Department of Health for 13 years. He is well-known for funding needle exchange, creating Healthy San Francisco, outlawing the sale of tobacco at pharmacies, and winning ballot measures for rebuilding Laguna Honda Hospital and San Francisco General Hospital. He is a graduate of Yale College and Harvard Medical School. He completed an internal medicine residency at UCSF Medical School and was an RWJ Clinical Scholar.

He is the Deputy Editor of JAMA Internal Medicine, an elected member of the National Academy of Sciences (previously the Institute of Medicine) and the recipient of the Los Angeles County Medical Association 2015 Healthcare Champion of the year.

# Leah LaRusch MSPAS, PA-C, RT (N)

#### Director UNM APP General Surgery Fellowship and PA Emergency General Surgery at UNMH Department of Surgery

Leah LaRusch began her career in science as a research technician at the UNM Cancer Research Facility, performing bench side experiments in cell signaling, focusing on the role of arrests in N-formyl peptide receptor (FPR) trafficking. She worked as a nuclear medicine technologist in Albuquerque for 8 years at the VAMC and Presbyterian Downtown Hospital, and ultimately became a PA in 2015 and has been practicing in Emergency General Surgery at UNMH ever since. LaRusch is mother to a beautiful baby girl, as well as to fur babies, and is a yoga and fitness enthusiast.

#### Garrett Matlick, BSN, MSN, MPH, FNP

#### Family Nurse Practitioner at Community Health Center, Inc.

Garrett Matlick is a Family Nurse Practitioner at Community Health Center, Inc. at CHCI's Stamford location and a graduate of CHCI's NP Residency '18-'19 cohort. Since that time, Matlick has completed an accelerated BSN at the University of Missouri-Kansas City and both his MSN and Master of Public Health at Johns Hopkins University in Baltimore, MD, where he served as adjunct faculty for the Public Health Nursing course. While at Johns Hopkins, he also completed two graduate certificates in Applied Epidemiology and Environmental and Occupational Health. Matlick is currently enrolled in a Doctor of Nursing Practice program at Rush University with a specialty focus as a Psychiatric Mental Health Nurse Practitioner, as he plans to explore the role of a dual-certified FNP/PMHNP. His professional interests lie in substance use disorders, dual diagnosis, prevention of psychiatric re-hospitalization, as well as the development of NP residency/fellowship programs and dissemination of related research. # Nancy Noyes, RN, MS, PPCNP-BC, PMHCNS-BC

# Fellowship Program Director for the Child and Adolescent PMHNP Postgraduate Fellowship and Child and Adolescent Psychiatric Nurse Practitioner at Nationwide Children's Hospital

Nancy Noyes is the Fellowship Program Director for the Child and Adolescent PMHNP postgraduate fellowship and Child and Adolescent Psychiatric NP at Nationwide Children's Hospital in Columbus, OH. She currently has been trained and serves as a site visitor for the National Nurse Practitioner Residency & Fellowship Consortium (NNPRFTC). Noyes was previously at St. Jude Children's Research Hospital on the Consult-Liaison service where she treated several children and adolescents with delirium. While at St. Jude, she also served as a palliative care NP as well as the Bereavement Coordinator, and developed and implemented the bereavement program at the institution.

Noyes is the former Clinical Director of the Child and Adolescent Neuropsychiatric Research Program at Cambridge Health Alliance and was involved in clinical trials in children and adolescents with bipolar disorder, psychosis, and autism spectrum disorders. She also worked at Boston Children's Hospital in the outpatient psychopharmacology clinic. Noyes had a private practice while living in Maine and provided psychopharmacology consultation to a larger Pediatric Primary Care group practice.

Noyes received her Bachelor of Science degree in Nursing from West Virginia University and her Master of Science degree in Nursing Administration from the University of New Hampshire. In 2000, she completed two certificates of advanced studies both as a Pediatric Primary Care and Mental Health Nurse Practitioner at Northeastern University in Boston, Massachusetts.

Since 1980, Noyes has presented many lectures both locally and nationally on such topics as pediatric cancer care, juvenile bipolar disorder, ADHD, childhood depression, and pediatric delirium. She has also served in administrative and educational roles as an advanced practice nurse.

Noyes is a member of the American Psychiatric Nurse's Association and a member of the Sigma Theta Tau Honor Society. She has also served on committees developing test questions for certification examinations.

# Luis Padilla, MD, FAAFP

# Associate Administrator for Health Workforce and Director of the National Health Service Corps at the Health Resources and Services Administration (HRSA), U.S. Department of Health and Human Services

The Bureau of Health Workforce (BHW) aims to better meet the need for a well-trained, well-distributed 21st century workforce by strengthening the health workforce and connecting skilled professionals to communities in need. With an annual appropriation of more than \$1.5 billion, the bureau administers over 40 workforce programs with a staff of more than 450. BHW improves access to quality health care by developing, distributing, and retaining a diverse and culturally competent health workforce. The bureau supports the health care workforce accoss the entire education and training to service continuum—from academic training of nurses, physicians, and other clinicians to clinicians currently providing health care in underserved and rural communities across the United States.

Dr. Padilla was appointed associate administrator for the bureau of health workforce in May 2016. He also serves as director of the National Health Service Corps, BHW's largest program, with a field strength of approximately 13,900 clinicians nationwide.

Prior to joining BHW, Dr. Padilla was senior health policy advisor to the CEO of Unity Health Care in Washington, D.C., a federally qualified health center network with over 100,000 patients. A committed advocate for the underserved, Dr. Padilla is a former NHSC Scholar who completed his service at Unity's Upper Cardozo Health Center, where he also served as its medical director. He served on the National Advisory Council of the NHSC from 2007 to 2010.

A board-certified family physician, Dr. Padilla received a Bachelor of Arts in philosophy and a Bachelor of Science in biology from the University of California at Irvine. He earned his medical degree from Wake Forest School of Medicine and completed his family medicine residency at Brown University.

# Susanne J. Phillips, DNP, APRN, FNP-BC, FAANP, FAAN

#### Associate Dean of Clinical Affairs and Clinical Professor at the University of California, Irvine

Dr. Phillips is a board-certified Family Nurse Practitioner with experience in primary care serving in community, private, academic, and entrepreneurial practice since 1996. As the Associate Dean of Clinical Affairs and Clinical Professor at the University of California, Irvine, she serves as an educator teaching health policy, legal and professional issues in nursing, and advanced pharmacology while chairing the NP faculty practice within the Sue & Bill Gross School of Nursing.
