Dear Friends and Colleagues,

We are off to the races in 2024 with great optimism for a very successful year for the Consortium. The basis for my optimism is in the ground work that was laid by the Consortium in 2023, thanks to the tireless efforts of staff, board, and volunteers. A year ago, we launched a new name for this organization that was more than rebranding. It represented a bold step forward that recognized our past decade of work building the movement for high quality postgraduate residency and fellowship training for new nurse practitioners (hence our original name, NNPRFTC) and embraced a future that included joint NP/PA postgraduate training programs (hence our new name—Consortium for Advanced Practice Providers). We are excited about the growth potential this change affords the Consortium, and even more excited that we are continuing to grow our already striking contribution to the healthcare workforce in this country. We have forged new relationships, welcomed new ideas, and expanded our vision for both growth of the model, and growth of our accreditation business.

One of our core responsibilities of the Consortium is the comprehensive in-person site visit by a team of CAPP accreditation specialists that digs deep into the evidence for high quality and adherence to the Consortium's Accreditation Standards. I have been struck, in reviewing the reports of the site visitors, how far the model has come even in just the past few years to more deeply embrace and achieve the standards, including our newer standards for diversity, equity and inclusion training as part of the curriculum along with wellness promotion and resilience—so vital for the long-term success of our Residents and Fellows.

As I write this report every year, I comment on the tremendous changes underway in the political, social, technical and environmental forces that impact our society in general and healthcare specifically. The coming year will be no exception for healthcare, from rapid advances in the use and reach of artificial intelligence to the persistent and worsening shortages of primary care providers, psychiatric/mental health providers and other specialty providers.

The Consortium is proud of the contribution that we are making to ensure that the goal of excellent, comprehensive health care for all is not impeded by a lack of clinically expert, compassionate, and committed health care providers. Executive Director Report



As the Executive Director of the Consortium for Advanced Practice Providers, I'm always watching for data and developments related to healthcare. Although I've been aware of U.S. aging trends for some time, it's only recently that I began to look at them closely, and they're eyepopping: By 2030, every baby boomer will be 65 or older, and by 2060, this group will make up an unprecedented 23% of the population. At the same time, more than 600,000 Americans will be 100 years old and older.

The graying of America has profound workforce implications for every healthcare organization, many of which are still coping with the post-COVID exodus of front-line providers from the field. The need for more providers throughout healthcare will soar in the coming decades. I would argue that the demand for advanced practice providers will be especially acute. Because of all this, we must continue to work hard to recruit good

people, but we also need to train, in order to **retain**, both new and experienced providers in how to practice self-care. Our Nurse Practitioners and Physician Assistants/Physician Associates, who are already filling large voids in clinical care, are critical investments, and our society and institutions must treat them as such.

The Consortium for Advanced Practice Providers is already playing an important role in this area. Our recently revised 2023 accreditation standards require all postgraduate APP training programs seeking accreditation—those for NPs, PAs and joint NP/PAs, to teach wellness promotion and coping strategies to help mitigate burnout and compassion fatigue.

But our revised standards also look outward, at our nation's diverse, underserved populations. Postgraduate APP Training Programs must address health disparities and systemic racism in healthcare delivery, while promoting diversity, equity, and inclusion. Underserved and at-risk populations must be identified. And programs must address existing and emerging health problems related to climate change, because these are surely not going to lessen in the coming decades.

2023 was a busy year for us. One measurement is that while the Consortium has accredited a total of 32 postgraduate APP programs since 2015, as of now, 30 programs are in the pipeline for 2024! We have seen a significant jump in the number of joint NP/PA postgraduate training programs seeking accreditation, and we recently submitted our Expansion of Scope petition to the U.S. Department of Education to become a federally recognized accrediting agency for joint NP/PA Postgraduate training programs. We will be hosting our annual site visitor training course in the spring so we can add on to the 45 site visitors we currently have. We are currently accepting applications, and have a robust group already signed up. What has been really great to see is the number of alums of APP postgraduate training programs becoming accreditation site visitors, 30% of our site visitors are alumni of accredited programs.

For potential funding opportunities, and for sheer excellence-promotion, accreditation has become the national standard. But be aware that for us at the Consortium, accreditation is not the last step of the process, but instead the first. You will never have to recreate the wheel. We are here to support you.

I'd like to end with an anecdote. Last summer, at the conclusion of our high-energy 6th Annual Conference in Washington, D.C., we asked the 150+ attendees to define what the Consortium means for them. The three most frequently cited words were: "Collaboration," "Support," and "Community." I think these three words describe the Consortium beautifully and I'm gratified by the enthusiastic response to what we're doing. "Collaboration, Support and Community" will be the theme for the 7th Annual Conference, which will take place in sunny San Diego, California on July 21–23, 2024. I hope to see you all there!

As we said in Washington last summer: "What started off as a model has become a movement, and all our Consortium members are part of this important movement."

If you haven't already, please consider becoming a member of the Consortium's growing network of postgraduate training professionals. As a member, you are not only demonstrating your support for the APP postgraduate training movement but joining a collaborative learning community.

Here's to 2024 and all that we will do together to make it a joyous and successful year. Stay well!

2023 **Updates**

Accreditation:

Ten Postgraduate APP training programs received initial accreditation, one program received renewal of accreditation, thirty programs are in the accreditation pipeline for initial accreditation and ten programs for renewal of accreditation in 2024. Details on page 4-5.

Membership and Membership Community Forums:

In 2023, our network of postgraduate NP, PA and joint NP/PA residency and fellowship programs and professionals grew and increased by 33% since 2022. The Consortium currently has 325 members across 48 states.

The Membership site and Community Forums provided a platform for our membership community to network, and to participate in dynamic discussion boards and share resources and best practices. New in 2024, the Consortium will begin hosting regional membership meetings where postgraduate APP programs within the same geographical area can come together and collaborate.

Sixth Annual Conference—"Transforming Advanced Practice Postgraduate Training Stronger **Together: Setting the Standards**"

Our 2023 Conference was held in-person on July 23–24, 2023 in Washington, D.C. New in 2023, we offered a Pre-Conference Workshop for Preceptors. Both the Pre-conference workshop and 2-day conference were a major success! Of the 150 conference attendees, 100% of the evaluation respondents stated they were "strongly satisfied" or "satisfied" with all dimensions of the 6th Annual Conference. See story on page 7-9.

National Webinars, Training and other Offerings:

To ensure engagement and value to membership we responded to our members requests and provided the following offerings in 2023:

- Bi-Annual All-Members meetings
- Preceptor trainings and preceptor development webinars
- "Incorporating Diversity Equity and Inclusion into your APP Postgraduate Training Program" webinar
- Presentation on "Reducing Burnout and Promoting Wellness"
- Hosted guarterly "Accreditation Salons" to support postgraduate programs in the accreditation pipeline
- Developed the national listing of postgraduate APP programs, where there are now 535 Postgraduate APP Training programs nationwide. (as of 12/31/23)
- Provided an intense, two-day accreditation site visitor training course for new site visitors
- Explored hosting a universal matching program for APP Postgraduate training candidates and programs
- Launched a national survey aimed at gathering foundational data on Postgraduate APP training program salaries and support results coming in 2024!

The Consortium Submits its Expansion of Scope Petition to the United States **Department of Education**

The Consortium is seeking an expansion of its scope of recognition to include the accreditation of joint Nurse Practitioner and Physician Assistant/Associate Postgraduate Training Programs and has the required accreditation standards and policies in place that meet the criteria for recognition.

While the Consortium has been accrediting joint NP/PA postgraduate training programs since its inception, it is currently not federally recognized by the Department of Education as an accrediting agency for joint NP/PA Postgraduate programs. Given the value that accreditation brings to the public and to the health care system, and the Consortium's ability and interest in providing such accreditation services, the Consortium seeks to add accreditation of joint NP/PA postgraduate training programs to its U.S. Department of Education approved scope of recognition.

The Consortium will present its petition to the National Advisory Committee on Institutional Quality and Integrity (NACIQI) in February 2024.







Accreditation Activity in 2023

We continue to solidify our national position as the accreditor of postgraduate NP, PA and joint NP/PA residency and fellowship training programs. We serve the public and our stakeholders by accrediting these APP Postgraduate programs and publishing the outcomes of those reviews. We pride ourselves on the consistent quality of our professional yet collegial approach to ensuring a rigorous, voluntary, peer-review accreditation process.



In 2023, ten programs received initial accreditation: **Erie Family Health Center**'s AdvancingPractice Family Nurse Practitioner Fellowship, **Erie Family Health Center**'s AdvancingPractice Pediatrics Nurse Practitioner Fellowship, **Erie Family Health Center**'s AdvancingPractice Adult Gerontology Nurse Practitioner Fellowship, **Erie Family Health Center**'s AdvancingPractice Certified Nurse Midwife Fellowship all in Chicago, IL; **Holyoke Health Center**'s Family Nurse Practitioner Residency Training Program in Holyoke, MA; **Seattle Children's Hospital** Neonatal APP Fellowship Program in Seattle, WA; **Shasta Community Health Center**'s NP/PA Postgraduate Fellowship Program in Redding, CA; **UC Davis Health**'s Advanced Nurse Practitioner Primary care Residency in Addiction, Chronic care, Telehealth, Improvement Science, Collaboration and Equity (Advanced NP-PRACTICE) and **UC Davis Health**'s Advanced Practice Fellowship in Sacramento, CA and **East Boston Neighborhood Health Center**'s Family Nurse Practitioner Residency in Boston, MA.

One program received renewal of accreditation: Seattle Children's Hospital Advanced Practice Provider Fellowship in Seattle, WA.

Thirty programs are in the accreditation pipeline for initial accreditation and ten programs for renewal of accreditation in 2024.

2023 Accreditation Standards Released

In January 2023, in conjunction with the organization's new name and rebranding we also revised our accreditation standards and all accreditation materials to include Physician Assistants/Associates.

The Consortium's Accreditation Standards Review Committee began the process of revising its Accreditation Standards for postgraduate NP, PA and joint NP/PA training programs back in 2021.

The Consortium's accreditation standards were initially adopted in December 2015 and last revised in October 2019. The United States Department of Education requires Federally recognized accrediting agencies to review and revise (if appropriate) its accreditation standards no less than every five years.

In addition to becoming more inclusive to physician assistants/associates in the accreditation standards, we used this opportunity to include other important elements to the standards. Including: adding wellness promotion programs and coping strategies to help mitigate burnout and compassion fatigue to trainees and staff. Our revised accreditation standards look outward, at our nation's diverse, underserved populations. Postgraduate APP Training Programs seeking accreditation must address health disparities and systemic racism in healthcare delivery, while promoting diversity, equity, and inclusion.

Accreditation Site Visitor Training Course: "A Day in the Life of a Site Visitor"

Course Details:

The two-day, CE-approved accreditation site visitor training course uses a hybrid, web-based, simulation model to train site visitors to the Consortium's accreditation philosophy, practice and process.

The course structure is very deliberately designed to include presentations, team-based work, group discussions, and use of simulation videos. We developed a course resource center that offers information, best practices and examples of protocols. Site Visitor trainees were provided with videos of simulated site visits, a mock self-study, and mock site visit teamwork throughout the course.

Course Goals and Objectives:

Purpose (Goals)

This training series is designed to:

- Provide a deep appreciation and understanding of the Consortium's approach to accreditation site visits.
- Simulate the site visit: "A Day in the Life of a Site Visitor".
- Build the relevant knowledge, skills and attitudes for site visitors new to the Consortium.

Objectives (Participant Outcomes)

By the end of this training, participants will:

- 1. Know the Consortium's Standards, their elements, and the rationale for each standard.
- 2. Appreciate the Consortium's approach to accreditation.
- 3. Understand the components of the site visit.
- 4. Complete a draft narrative for each section of the mock site visitor's report.
- 5. Discuss best practices, potential pitfalls, challenges and barriers to verifying whether or not the program met the Standards.

The Consortium will be offering the 2-day site visitor training course again on Saturday, April 6th and Saturday, May 4th, 2024.

The sixth annual Consortium Conference, *Transforming Advanced Practice Provider Postgraduate Training—Stronger Together: Setting the Standards*, took place in-person on Sunday, July 23 and Monday, July 24, 2023 in Washington, D.C. This two-day CME-approved conference included keynote speakers, panel presentations, breakout sessions, and exhibitors, and provided the opportunity for a specialized focus on critical elements of curriculum, evaluation, faculty development, and accreditation. The two-day event brought together 150+ participants to learn from each other and also from experts in healthcare systems and policy and Postgraduate NP and joint NP/PA training.

New in 2023, the Consortium offered a Pre-Conference Workshop on Preceptor Development on Saturday, July 22, 2023. Over 50 APP preceptors participated in the Preceptor Workshop led by Radha Denmark, DNP, FNP-C, FHM. The Workshop was so successful that we will be returning the Preceptor Workshop at the 2024 conference in San Diego, CA.

HRSA aims to improve the health of the underserved population by the strengthening the workforce and connecting skilled professionals to communities in need. With HRSA's mission and the projected workforce shortages, there are several expected funding opportunities upcoming for 2023–2024. Over the past several years, HRSA's funding has grown to a budget of \$1.82 billion."




