The program's leadership has been recently spotlighted in The Journal for Nurse Practitioners with their publication of <u>"Development</u> and Accreditation of an Advanced Practice Provider Fellowship at an Acute Care Pediatric Hospital." This seminal article details the journey of creating a postgraduate training fellowship program and becoming accredited. Rooted in excellence and innovation, the fellowship offers a unique blend of immersive clinical experiences, specialized training, and mentorship opportunities, setting a new standard for professional development in pediatric care. The mission of the APP Fellowship Program at Seattle Children's is to support newly graduated APPs, or APPs with limited pediatric experience, in successfully entering their practice in a complex, highly collaborative pediatric setting.

- Who we Train: PNP PC & AC, FNP, PA-C
- Year Started: 2017
- Year Accredited: 2020
- Number of cohorts per year: 3
- Number of fellows per cohort: 6-10
- Number of fellowship graduates: 109
- Number of graduates hired on permanently: 93

A few innovative approaches, key findings, and lessons learned: Each fellow assigned a "Fellowship Educator" who acts as clinical coach, providing support and feedback throughout the year.



SCH APP Fellowship Class Outings

Medical Advisor – Physician who is part of APP Fellowship faculty, provides education, acts as supervising physician of PA-Cs, acts as a liaison with hospital physicians working with APP Fellows.

We do not train APP Fellows on a specialty track, rather we orient them to general acute care pediatrics and give them opportunity to rotate through various areas of the hospital to provide well-rounded pediatric training. At the end of their fellowship, they choose to apply to available jobs at the hospital that align with their goals and interests. Fellows often find they develop new or different interests from when they started the program.

We tried specific specialty tracks in the beginning (urgent care, emergency department, cancer care) but found it to be unsuccessful for several reasons:

- Occasionally fellows changed their minds and decided to pursue other specialties
- Sometimes there were no open jobs within that specific specialty upon fellowship graduation

Having fellows trained to multiple areas in the hospital is helpful during times of surge related to increased volumes or hospital staffing issues. APP Fellows have been deployed to fill staffing holes in the inpatient medical services, and the Emergency Department.
