### Luzann Ampadu, DNP, MS, FNP-BC

Luzann Ampadu earned her BS and MS FNP degrees from the University of Rochester, SON, and recently graduated in the first DNP cohort from SUNY Brockport. Additionally, she has worked the past 10 years as a practicing FNP and taught the past 4 years as an adjunct professor in the FNP program at SUNY Brockport. Currently, Luzann, works full-time at Highland Family Medicine, a safety-net practice, where she splits her time between clinical care and as the Academic Director for the UR HFM FNP Residency Program. She is passionate about primary care, interprofessional education, and teaching family nursing and has precepted nurse practitioner students and nurse practitioner residents for over 7 years. She has held leadership positions as Co-Coordinator of CenteringPregnancy at HFM and spearheaded a committee on Diversity issues. Prior to this, Luzann held the lead NP position at Starlight Pediatrics Foster Care Clinic for Monroe County Department of Public Health. She is an active member of the HFM ANCC, NAPNAP of the Rochester Black Nurses Association (RNBA). Luzann has 2 wonderful children and 2 adorable cats.



#### Lindsey Anagnostopoulos, MSN, ARNP, FNP-C

Lindsey Anagnostopoulos is a nurse practitioner and Residency Site Director for Sea Mar Community Health Centers. She graduated from Sea Mar's post-graduate training program as part of their inaugural class in 2016. After establishing a practice at Sea Mar Everett Medical, she returned to the training program as a faculty preceptor and later transitioned into the leadership role of Site Director to support Sea Mar's expanding program. Her contributions to the program include leading a collaborative faculty development series and a program enhancement committee that utilizes rapid cycle improvement processes. At Sea Mar Everett, Lindsey leads the region's colposcopy clinic and provides care as a Washington Health Care Authority Autism Center of Excellence Provider. Outside of her work at Sea Mar, Lindsey serves as a Site Visitor for the Consortium and as a Nexplanon Clinical Trainer for Organon.



### Deb Bakerjian, PhD, APRN, FAAN, FAANP, FGSA

Deb Bakerjian is the associate dean for practice and a clinical professor at the Betty Irene Moore School of Nursing at UC Davis. As the associate dean for practice, she leads the school's clinical enterprise, including oversight of clinical faculty practice development and implementation, UC Davis Health and community strategic partnerships and advocacy, interprofessional practice and clinical partnerships and strategies for the school's contribution to the Healthy Aging Clinic.

Bakerjian's research aims to improve the quality of care for aging populations. Her research focuses on patient safety and quality improvement practices in long-term care, particularly nursing homes, as well as interprofessional education and collaborative practice in primary care. She is specifically interested in the roles of nurse practitioners and physician assistants as members of the interprofessional team. As a founding faculty member, she was instrumental in transitioning the family nurse practitioner and physician assistant programs from the School of Medicine to School of Nursing and establishing both as master's degree programs.

Bakerjian led several workforce enhancement grants funded by the Health Resources and Services Administration (HRSA) over the last decade. Currently, she is the director for the primary care nurse practitioner residency program, a primary care training enhancement grant for physician assistants and nurse practitioners, as well as a grant to enhance the skills of registered nurses in public health. She recently received an additional \$4 million from HRSA to develop a nurse-led mobile clinic. Bakerjian is also the co-principal investigator and co-editor-in-chief for the Agency for Healthcare Research and Quality (AHRQ) Patient Safety Network website and co-principal investigator for Cal Long Term Care Compare, a statewide website that provides data to consumers on the quality of long-term care organizations such as nursing homes.

Bakerjian was a Pat Archbold Predoctoral Scholar and a Claire M. Fagin Postdoctoral Fellow at UC San Francisco in the Department of Social and Behavioral Sciences, where she was also an assistant adjunct professor. She earned a Doctor of Philosophy in Health Policy and Gerontology in 2006 and a Master in Science of Nursing in 1992, both from the UCSF School of Nursing. Her doctoral study, "Utilization of Nurse Practitioners in Nursing Homes: A Comparison with Physicians," received the 2006 Dissertation of the Year Award at UCSF. Bakerjian earned both a family nurse practitioner and physician assistant certificate from the UC Davis School of Medicine in 1991 and a Bachelor of Science in Health Services Administration from the University of Phoenix in 1983. She received an Associate Degree in Nursing from Evergreen Valley College in San Jose, California, in 1977.

Bakerjian participates in a variety of areas of service in the health system. She is the co-chair of the clinical delivery committee for the UC Davis Health Aging Initiative and is a member of the UC Davis Health resource utilization committee. Bakerjian is active in both state and national organizations associated with nursing, patient safety and quality, and the care of older adults. She is chair of the board of directors for HealthImpact, the California Nursing Workforce Center. She serves on the National Quality Forum's Skilled Nursing Facility Technical Expert Panel for Serious Reportable Events and Common Formats. She is on the Governance and Transitions of Care committees for AMDA—The Society for Post-Acute and Long-Term Care and is a past president of the California Association of Long-Term Care Medicine and the Gerontological Advanced Practice Nurses Association.

She is a fellow in the American Academy of Nursing, the American Association of Nurse Practitioners, Western Academy of Nurses and the Gerontological Society of America.



### Kerry Bamrick, MBA

Kerry Bamrick is the Executive Director of The Consortium for Advanced Practice Providers ("the Consortium"). In this role, she serves as the key management leader of the Consortium. Bamrick is responsible for overseeing the administrative, fiscal, and technical, programs, and services of the Consortium while carrying out the strategic plan of the organization. As the Executive Director, key responsibilities include oversight of the development, implementation, and operation of the Accreditation Commission of the organization in accord with the rules governing that Commission, supporting the business growth and development of accreditation business for the Consortium, and maintaining its Federal Recognition as an accreditor by the U.S. Department of Education. Over the last sixteen years, she has been directly involved in the growth and development of the organization including moving it from an informal group of six organizations to becoming its own 501c3.

Her research has focused on the role of nurse practitioners and other primary care providers in nurse managed and traditional primary care settings. Dr. Benkert has received numerous Health Resources and Services Administration (HRSA) and foundation grants. She is the principal investigator (PI) for the Area Health Education Center (AHEC) in Michigan, which has received 14 years of continuous funding from HRSA.

## Carlin Chi, MD

Dr. Carlin Chi is the Medical Director of Primary Care at Petaluma Health Center and a member of the core faculty of the PHC Nurse Practitioner and Physician Assistant Residency Program. After graduating from Harvard Medical School, she completed a three year family medicine residency focusing on care of underserved populations at UCSF-San Francisco General Hospital in the Family and Community Medicine department. After residency she worked with community health centers affiliated with San Mateo County as lead physician at both the South San Francisco and Daly City Youth Health Centers. She also provided first trimester abortion training for family physicians through UCSF's Advancing New Standards in Reproductive Health (ANSIRH) program Training in Early Abortion for Comprehensive Healthcare (TEACH). She holds volunteer clinical faculty appointments with Touro University and UCSF School of Medicine.

Dr. Chi joined the team at Petaluma Health Center in 2012, with primary responsibility for coordinating and planning student programs in addition to continuing her clinical practice. She became an associate medical director with leadership of a clinical team in 2015.

She completed the UCSF Family and Community Medicine Faculty Development Fellowship in 2016–17, and during the same year she led the health center team developing the NP/PA Residency Program while participating in the Weitzman Institute National Collaborative Agreement supporting new programs. The residency program launched in February 2018 with its first class of four residents. Since then, she has continued as core faculty of the program, participating in all aspects of the program including curriculum development, precepting, evaluation, accreditation, and expansion. She has also helped lead the creation of the second year fellow program, which allows resident graduates to continue their trajectory of supported career development within the health center.

In 2021, Dr. Chi became the Medical Director of Primary Care at Petaluma Health Center, with responsibility for supervising medical providers across teams and collaborating with operational, administrative, and nursing leadership to support the mission of delivering excellent care to underserved communities. This position has allowed her to combine her passion for teaching and mentoring new community health center providers with her lifelong goals of advocacy and care for underserved patients, hopefully with the result of helping to increase the numbers of family medicine providers choosing careers in community health centers across the state.

#### Charise Corsino, MA

Charise is the Program Director for Community Health Center, Inc.'s (CHCl's) Nurse Practitioner Residency Training Programs. Asefeh Faraz Covelli, PhD, APRN, FNP-BC, FAANP is an associate professor at the George Washington University School of Nursing. Her research focuses on nurse practitioner (NP) workforce issues, with emphasis on the novice NP workforce transition. Dr. Faraz Covelli has co-developed the Novice Nurse Practitioner Role Transition Scale and the Doctor of Nursing Practice Minimum Data Set. She has worked with major national organizations related to the education and workforce of NPs, and received funding from HRSA, The Robert Wood Johnson Foundation and the American Association of Colleges of Nursing. Dr. Faraz Covelli is a nationally-known expert in the area of NP workforce, having presented several popular national webinars and is also co-editor of a forthcoming transition to practice book for NPs.



### Kathryn Cronin, MSN, ACNP, ACHPN

Kathryn Cronin has been a Lecturer for UCLA School of Nursing for 6 years in the Adult-Gerontology Acute Care APRN program and has over 23 years of experience in the nursing field. Her other professional endeavors include mentoring quality improvement projects, practicing addiction medicine, and teaching research and QI at UNM's College of Nursing. ## Patricia Dennehy, DNP, NP-C, FAAN

Dr. Dennehy is currently working with the LA County Department of Health Services (LACDHS) on projects examining the roles of advanced practice providers throughout the system. She led the planning and is currently working with the leadership to complete the first NP Postgraduate Residency cohort. Also included in this contract is a Professional Advancement Model, and evaluation of organizational standards for employment and practice.

Prior to her work in LA, she was a Principal Consultant for Health Management Associates. She led many projects including a 3-year grant with the State of Idaho taking 55 primary care practices through Primary Care Medical Home (PCMH) recognition/certification a year (total 165 practices over project period).

Dr. Dennehy had a long, rich history at the University of California San Francisco (UCSF). She had clinical practices in Women's Health and Adult Internal Medicine. She was a Professor of Nursing and Director of Glide Health Services

in San Francisco. Glide was a collaboration between the School of Nursing, Glide Foundation, Catholic Healthcare West—Saint Francis Memorial Hospital and the SF Department of Health Services. Her work included leading projects funded by a variety of sources including multiple grants from HRSA Division of Nursing and Public Health and many private foundations. She was the author and Project Director of the first HRSA grants for NP Residencies granted to UCSF/Glide and included UCLA as a sub-recipient.

Dr. Dennehy is a healthcare leader and strong spokesperson for nursing's and advanced practice providers' contribution to healthcare access and quality. She served on the Board of Directors for the following organizations: National Nurse Practitioner Residency & Fellowship Training Consortium (NNPRFTC), National Nursing Centers Consortium and the San Francisco Community Clinic Consortium. In her work with the NNPRFTC, she was a founding member, is Vice Chair of the Board of Directors, and Chair of the Membership Committee.

Dr. Dennehy received her BSN and FNP from Sonoma State University, MSN from the University of California San Francisco and DNP from Rush University. In 2012, she was the recipient of the James Irvine Leadership Award for her "creative and inspirational leadership benefiting the people of California" for increasing the access to primary care through the use of nurse practitioner providers in expanded roles. In 2014, she received the Dr. Francis Curry Award for promoting the role of nurses in primary care.



#### Mitchel Erickson, DNP, BSN, MSN, ACNP

Dr. Mitchel Erickson is a board-certified acute care nurse practitioner who practiced as an emergency medicine provider for 25 years but has worked as a hospitalist and primary care provider. His leadership roles include the first UCSF Health's Chief of Advanced Practice overseeing 600 APPs and the Chair the California Board of Registered Nursing's Advanced Practice RN Advisory Committee. His role as Chief helped mobilize advanced practice leadership across all University of California health systems to address common practice and administrative optimization. During his tenure in the role, he focused on APP new hire onboarding to address provider attrition and engagement and published the data in 2023. He is currently building and optimizing a 4-year collaboration between the Department of Emergency Medicine and Division of Geriatrics creating an age-friendly model of care in the emergency department. He maintains his role as a Clinical Professor position at UCSF School of Nursing and is a consultant to the Los Angeles County Dept. of Health Services APP workforce. He completed his Doctor of Nursing Practice degree at UCSF in 2022 focusing on medication self-management and medication reconciliation for older adults in the emergency department during the implementation of SB1254 and received the 2022/2023 American Association of Colleges of Nursing's Excellence in Advancing Nursing Practice award in recognition of his doctoral work.



## Shannon Fitzgerald, MSN, ARNP

Shannon Fitzgerald is a leader in nurse practitioner practice and regulatory issues, and has a passion for advancing the NP profession with a focus on the development and promotion of postgraduate training programs. She served as the first Chief for Advanced Practice at Seattle Children's Hospital, where she and her team created a large, robust Advanced Practice Provider Fellowship, and quadrupled the NP and PA workforce. A past chair of the Washington State Nursing Care Quality Assurance Commission, she currently serves as a pro tem Commissioner and on the State of Washington Advanced Practice Committee. She serves on the Consortium Board, as a site visitor, is on the Finance Committee, and was active in the revision of the Accreditation Standards.
